1. Who We Are

2. What Data We Collect

We may collect:

- Basic details name, address, contact information.
- Identity and proof of right to rent passport, driving licence, visa/immigration status.
- Financial details bank information, income, employment, credit history.
- Property ownership and landlord details (e.g. title deeds, mortgage permissions).
- Special category data where necessary (e.g. health details to tailor services).
- Criminal conviction data if required for referencing or licensing.
- Website and communication data (IP address, cookies, call logs).

From May 2025, we are also required to conduct Anti-Money Laundering (AML) and sanctions checks, which may involve verifying identity, address, property ownership, and screening against official government lists.

3. Why We Use Your Data

We use your personal data to:

- Provide letting, sales, management, and property services.
- Meet legal obligations (e.g. tenancy deposit protection, Right to Rent, AML checks).
- Carry out referencing and contract administration.
- Communicate with you about services, viewings, and tenancy or sales matters.

- Send you marketing communications (only with your consent you can opt out anytime).

4. Sharing Your Data

We may share your data with:

- Utility companies and local councils.
- Deposit protection schemes.
- Regulatory authorities (e.g. HMRC, ICO, Local Authorities, NCA for AML reporting).
- Our software providers (e.g. SME Professional, LifeSycle, PayProp, FixFlo, Southwest Inventories, TouchRight, Signable, Jot Form, Google Form, 1090, Vouch, TDS and DPS).
- Other third parties only where legally required or with your consent.

We will never sell your data.

5. Transfers Outside the UK

Where data is transferred outside the UK, we ensure appropriate safeguards are in place in line with UK GDPR, such as International Data Transfer Agreements.

6. Legal Basis for Processing

We process data under the following lawful bases:

- Contract to provide tenancy, sales, and property services.
- Legal obligation e.g. AML, Right to Rent, deposit protection, safety checks.
- Consent for marketing communications.
- Legitimate interests to operate and improve our services, prevent fraud, and maintain efficient business operations.

7. How Long We Keep Data

We keep your data only as long as necessary:

- Enquiry data up to 6 months.
- Tenancy/landlord/sales files up to 6 years after the relationship ends.
- AML and financial records 5 years as required by law.
- CCTV/phone logs as set out in our security policy.
